A major merger in the optical measurement systems market. Baker Tilly Woroszylska Legal was the advisor.

This unusual merger project of three companies was successfully completed at the beginning of January 2021, when the companies 3D TEAM and 3D TOOL joined LENSO. The next step the company is already planning is a new Automation Team that will focus on in-line coordinate measurement. The activity is to be further extended to the measurement of static and dynamic deformations.

What triggered the merger of these entities?

This merger seems to have been a natural process. All companies are active in the measurement systems industry. Lenso is the exclusive distributor of GOM optical measuring systems in Poland. Their engineering team provides assistance in selecting the right measurement system, device demonstrations, implementation and support. In addition, it provides training in 3D metrology. 3D Tool is involved in the implementation of measurement equipment, automation and optimisation of measurement processes. 3D Team is a provider of measurement services for industry.
