

# ENERGY PRICE FREEZE 2024 BENEFITS FOR THE SME SECTOR

On 15 December 2023, the President of the Republic of Poland signed an amendment to the law on emergency measures in the area of electricity prices.

During the legislative process, changes were made to the original draft amendment, broadening the group of beneficiaries by including micro, small and medium-sized entrepreneurs (SME).

The solutions introduced by the law will therefore support not only households, but also companies. The new legislation obliges energy entities to apply frozen electricity prices to SME customers until **30 June 2024**.

The maximum price was set at a level of PLN 693/MWh.

## **Required statement**

The procedure for inclusion in the favourable price requires a declaration to be submitted either on paper or electronically by **31 January 2024**.

An exception is made for entities that have already submitted a declaration before the end of 2023 - for them, there is no need to resubmit the documents, as long as they had eligible recipient status on 31 December 2023 and meet the related criteria on 1 January 2024. It is worth remembering that in the event of a change in circumstances affecting the entitlement to use the maximum price, the eligible customer is obliged to notify the energy supplier with in **7 days** of the change occurring.
